- 1. <u>Enroll Through ProSeries Options Set-up Wizard</u> Select Pay-by-Refund in the Options Set-up Wizard in your TY15 ProSeries software. If you've already completed set-up, the Options Set-up Wizard is accessible from the Help menu in ProSeries. After selecting Pay-by-Refund you will be directed to enroll with one of our participating banks (see below). Enter your name, e-mail address, and EFIN and submit your enrollment to the bank. This enrollment lets the bank know you are an authorized ProSeries user and that an application is coming.
- 2. <u>Apply With Selected Bank</u> Next, the Options Set-Up Wizard will direct you to the web site of the bank you selected where you will complete and submit your application. You can also access the application on the bank's web site via the bank enrollment links in the table below. The bank will be in contact with you regarding your application.
