Accurate paychecks: We assume responsibility for paychecks based on the data you supply. As long as the information you provide us is accurate and on time, we guarantee that your paychecks will be accurate and on time – or we will give you the next monthly payroll fee for free and we will pay, if any, resulting bank fees. Inaccurate paycheck(s) claims must be submitted to Intuit within forty-five (45) days of the applicable pay date. Guarantee terms and conditions are subject to change at anytime without notice.

Subscription, Internet access, Federal Employer Identification Number (FEIN), and U.S. billing address required. E-File & E-Pay feature is available for federal and most state tax payments. 24/7 access is subject to occasional downtime. Terms, conditions, features, pricing, service and support are subject to change without notice.

Obtaining an Intuit Pay Card: The USA PATRIOT Act is a federal law that requires all financial institutions to obtain, verify, and record information that identifies each person who opens a Card Account. What this means for your employees: When you open a Card Account, we will ask for your employee's name, address, date of birth, and other information that will allow us to reasonably identify them. We may also ask to see their driver's license or other identifying documents at any time.
