

Assisted Payroll - Copy Request for Filed Payroll Tax Forms

Save time by accessing your filed copies securely through QuickBooks!

Here's how:

QuickBooks version 2006 and later customers:

- 1. In the Payroll Center, select View/Download Tax Forms.
- 2. Enter your payroll PIN when prompted.

QuickBooks version 2005 customers:

- 1. From the Employees menu, select Payroll Services, then View/Change Payroll Service Account Information.
- 2. Select the **View/Download Tax Forms** link near the bottom of the page.
- 3. Enter your payroll PIN when prompted.
