Request for Copies of Filed Payroll Tax Forms (2002 and later)

If you are requesting copies because you received a tax notice, fax the notice to our Notice Resolution Group at 866.293.1994. You do NOT have to submit a request for copies of your tax forms.

Explanation of fees

Document fee	\$25.00 each	Fee for each document and filing period you request.
Historical research fee	\$100.00 for each year	This fee applies to each year prior to 2002 from which you request documents, and is in addition to the per-document fee listed above.

FAQs

- Customer tax return copies are delivered to Assisted Payroll customers via QuickBooks Payroll Tax Center. It is the customer's responsibility to log in and download all available copies every quarter. We no longer mail form packets.
- PTC can be accessed from any computer using this external link. Payroll PIN is required to log in. QuickBooks software is not required. https://payrolltaxcenter.intuit.com/ptc-termed/
- The turnaround time for copies is 24-48 business hours.
- Filed forms are available in the PTC 45 days after the quarter closes with exception to Annual Withholding, which is available March 5th of the following year.
- Form 941SA (Wage List) is no longer on a separate form. It is now included on the Quarterly Unemployment Return for all states.
- Most state withholding deposits are electronically paid. Intuit doesn't provide PDF copies of payments made on your behalf.
- If the Company had an Entity Change, you will not be able to see copies of filed tax forms for the old EIN in PTC.
- If you recently canceled your payroll service, use the URL provided in the cancellation email and your payroll service PIN to access your filed tax copies.
- Copies of amended returns can't be provided until the amendment case has been completed.
- Annual reconciliation not available for CA and NY.
