## Intuit Tax Online Win A Year Free Promotion Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: Intuit Tax Online Win A Year Free Promotion (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry and are entering on behalf of their employer or business (herein "Company"). - **3. Timing:** The Sweepstakes begins on November 11, 2011 at 12:00 a.m. Eastern Time ("ET") and ends on December 31, 2011 at 11:59 p.m. ET (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
- **4. How to Enter:** During the Promotion Period, visit http://proadvisor.intuit.com/product/intuit-tax-online/index.jsp, and follow the links and instructions to use the free trial of Intuit's Online Tax program ("try it free"). There are two (2) ways to register:
  - a. <u>Create an Online Account</u>: Create an online account by completing the registration process as defined by Intuit. By creating your own online account, your Company will automatically receive two (2) entries into the Sweepstakes.
  - b. <u>Register without Creating an Online Account</u>: Submit your name, valid email address and phone number as requested. By submitting this information, your Company will receive one (1) entry into the Sweepstakes.

Limit: Each entrant may receive up to two (2) entries on behalf of his or her Company during the Promotion Period. Companies may receive up to two (2) Sweepstakes entry for each entrant who enters on its behalf, but each entrant may only enter on behalf of his or her Company one (1) time by either of the methods described above. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email

addresses for the domain associated with the submitted address. Each potential entrant may be required to show proof of being an authorized account holder.

5. Grand Prize Drawing: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. ONE (1) GRAND PRIZE: Access for employees of winning Company to use Intuit's Proline Tax Online program for any individual or business tax returns prepared from November 1, 2011 through October 31, 2012. Usage may not exceed a maximum amount of \$10,000 based on product usage fees. Maximum Approximate Retail Value ("ARV"): \$10,000. Actual value of prize will vary based on actual usage by the winning Company. Winners will not receive difference between actual and maximum approximate retail value.

<u>TWO (2) RUNNER-UP PRIZES</u>: Winning Company's choice of use of Intuit's Proline tax online program to prepare one-hundred (100) individual tax returns (ARV: \$999), or twenty (20) business tax returns (ARV: \$499) for any employee.
