Works with Microsoft Excel version 2002 or later. It does not integrate with QuickBooks Simple Start. E-File & E-Pay feature is available for federal and most state forms and taxes. For states where E-File is not available, Intuit will provide signature ready forms or worksheets. Check state tax e-payment availability. In the unlikely event calculations are incorrect, Intuit will pay any penalties incurred. Customer must provide Intuit with a tax statement from the IRS, state or local agency showing a tax penalty incurred as a result of a calculation error during the time that you were an active Intuit Online Payroll subscriber. Client must present a copy of this letter to Intuit within 3 months of receiving the letter from the IRS. You are responsible for paying any additional tax liability you may owe and providing any other information Intuit reasonably requests. Terms, conditions, pricing, features, functionality, service and support are subject to change at any time without notice.

3. Tax Payments and Filings Guarantee: We assume responsibility for federal and state payroll filings and payments directly from your account(s) based on the data you supply. As long as the information you provide us is correct and on time, and you have sufficient funds in your account, we'll file your tax forms and payments accurately and on time or we'll pay the resulting payroll tax penalties. Guarantee terms and conditions are subject to change at anytime without notice.

4. Direct Deposit requires a currently supported version of QuickBooks, a QuickBooks Payroll subscription and Internet access. Nominal per transaction and per payroll transmission fees apply.
